## **1. § The Competition**

The Streetball 3x3 Basketball Championship (Streetball 3x3) is a 3-on-3 basketball (shortly called 3x3) recreational sports event in Hungary organized by the Hungarian Basketball Federation, launched by the International Basketball Federation (FIBA).

## **2. § About the government of the Streetball**

- 2.1 The MKOSZ exercises all powers over the teams and players entered for the competition, as well as all the participating persons, which are authorized by the legislation, the rules of the competition and the Competition Notice. The tournaments of the competition are conducted according to the rules and frameworks defined by FIBA, and are carried out by the organization commissioned by MKOSZ
- 2.2 The MKOSZ and the on-site organizing organization are entitled to act and make decisions in connection with the Competition Notice and the Official Game Rules of Streetball 3x3 in all matters related to the conduct of the competition. The MKOSZ, or the on-site organizing organization, acts ex officio or upon request in relation to controversial matters of Streetball 3x3. It makes its decisions and notifies the affected parties as soon as possible after the official detection or submission of the request.
- 2.3 Due to the specific nature of the competition series, there is no appeal against the decision of MKOSZ or the on-site organizing organization, its decision is final.
- 2.4 The official method of communication with the organizer of the competition and the organization conducting the on-site event is e-mail. The contact information of the on-site organization is published on the MKOSZ official website.

## **3. § The purpose of the competition.**

- 3.1 Broadly introducing the 3-on-3 game (3x3) launched by FIBA, competing the entered teams, culturally entertaining the audience, popularizing the sport among a wide range of young people.

## **4. § Duration of the competition**

- 4.1 **25<sup>th</sup> of May 2024. – 14<sup>th</sup> of September 2024.**
- 4.2 MKOSZ publishes the competition calendar of the tournament series on its official website and on the website [www.streetballnet.hu](http://www.streetballnet.hu).

## **5. § Competition participants, participation eligibility**

- 5.1 Teams of 4 people can participate in the competition, provided that the entry requirements have been met in a timely manner.

## 6. § Registration of participants

- 6.1 The documents required for the registration and the entry process accepted by FIBA are contained on the MKOSZ official website and the ENTRY GUIDE published on the [www.streetballnet.hu](http://www.streetballnet.hu) website.
- 6.2 Participation in the competition requires registration on the website [www.3x3planet.com](http://www.3x3planet.com) created and operated by FIBA.
- 6.3 The registration fee: HUF 16,000 per team, with the exception of the Nyíregyháza station, where, thanks to the support of the Szabolcs-Szatmár-Bereg County Association, it is HUF 8,000/team, which can be paid as follows:

The registration cannot be considered accepted until the entry fee is received!

## 7. § Method of conducting

The championship is held in a tournament system.

Qualifying tournaments:

8 regional tournaments between May 25, 2024 and September 14, 2024 (Budapest-Kőbánya, Szombathely, Nyíregyháza, Oroszlány, Zánka, Körmend, Veszprém, Budapest-Hősök Square). Category winners of the tournaments qualify for the final tournament.

## 8. § Dates of the match

8.1 The dates of the matches are determined by the organizer of the competition and the on-site organizing organization, which will be made known to the participants in due time.

### 8.2 Location and/or time changes

Only the organizer of the competition or the on-site organization is entitled to change the finalized dates and locations. Participants must be notified as soon as possible of a possible change of venue and changed match dates.

## 9. § Eligibility to play

9.1 Only duly registered players are entitled to participate in the Streetball 3x3 Basketball Championship matches.

9.2 Athletes without a license to play in the NB I/A group are eligible to participate in the Streetball 3x3 Basketball Championship.

### 9.3 Age categories:

KENGURU born after 1th of January at 2013.

born after 1th of January at 2012.

born between 2010-2011

born between 2008-2009

born between 2006-2007

born between 2001-2005

Open: open category in terms of age group (male, female)

+35: born before 1990 (male, female)

Mixed

When applying for the categories, the age of the oldest player is decisive, an older player cannot start in a younger category.

## 10. § Arrangement of matches

### 10.1 Venue of matches

MKOSZ selects the venue for the matches together with its organizing partner.

### 10.2 Obligations of tournament organizers

The organizers of the tournaments and the on-site organizing organization organize the events in compliance with the regulations of the MKOSZ and the legislation on the organization of sports events.

### 10.3 **The following must be observed at all tournaments:**

10.3.1 In every match, it must be ensured that

- a. Treatment of injuries resulting from sports activities should begin immediately, or
- b. In the event of a serious injury, the injured person should be taken to medical care immediately (notify an ambulance, transport to a medical emergency).

The organizers are not responsible for health problems that occur after the end of the tournament/match.

10.3.2 Before the start of the first match of the tournament, the referee must take his/her place at the table.

10.3.3 At the site, the participating teams must appear at the prescribed time at the representative of the on-site organization in order to complete the necessary administration and registration!

10.3.4 The players participate in the competition at their own risk, they acknowledge that they are in good physical condition, have their health checked regularly, and are not aware of any illness that would prevent their participation. If they suffer any damage, they will not make any claims or demands against the organizers of the competition. They are allowed to undergo a sports medical examination and accept the instructions of the competition doctors.

### 10.4 **Match ball**

Streetball 3x3 Basketball Championship matches can only be played with MOLTEN Libertria 33 type balls.

### 10.5 **Players' clothing**

In all matches: according to the announcement, you must play in the competition jersey provided by the organizers against the entry fee.

## 11. § Protest

11.1 The team participating in the matches of the Streetball 3x3 Basketball Championship can file a warning regarding the eligibility of a player to play, and if they believe that some event during the match adversely affected their interests and had an impact on the final result of the match.

11.2 The team representative is obliged to report the reason for the caution to the referee of the match immediately after the occurrence of the event, who immediately informs the representative of the on-site organization.

11.3 The warning is immediately assessed by the representative of the on-site organization and a final decision is made. There is no appeal against your decision!

11.4 A warning cannot be based on a wrong referee's decision! The warning referring to this is automatically considered invalid!

## **12. § Awarding**

- 12.1 The national first team of the categories of the Streetball 3x3 Basketball Championship will be awarded a medal and a certificate.
- 12.2 Participating teams and players may receive special prizes in addition to those mentioned, depending on the offer.

## **13. § Trainers**

- 13.1 Any natural person can coach at the matches of the Streetball 3x3 Basketball Championship, as long as their behavior complies with the relevant rules of the MKOSZ.

## **14. § Referees**

- 14.1 Only persons recognized by MKOSZ who have successfully completed the online 3X3 training and thus are officially authorized to officiate 3X3 matches may referee the matches.
- 14.2 The remuneration of the referees is paid at the venues by the representative of the MKOSZ organizing partner based on the official MKOSZ regulations.

## **15. § Expenses**

- 15.1 Participating teams are responsible for the cost of travel to the venue of the match and the cost of entry.
- 15.2 The costs of organizing the tournament (including the referee's fees) are borne by MKOSZ and the on-site organization.

## **16. § Responsibility of participants**

- 16.1 All participants of the Streetball 3x3 Basketball Championship are responsible for complying with these Competition Notices and other rules related to the competition.

## **17. § Information - statistics**

- 17.1 In the area of information and statistics, the participants must show full cooperation in order to ensure that the viewers and the media get maximum information.
- 17.2 The players can appear in film and image material from the tournament, so they do not ask for compensation. They consent to the organizers sending newsletters to the given e-mail addresses for more precise information.
- 17.3 The organizers ensure data management in accordance with the regulations contained in the relevant legislation, especially the LXIII of 1992. are handled in accordance with the Act (On the Protection of Personal Data and Disclosure of Data of Public Interest).

## **18. § Other regulations**

- 18.1 The Streetball 3x3 Basketball Championship 2024 Official Game Rules and the International Basketball Game Rules 2010 apply to the matches of the Streetball 3x3 Basketball Championship!
- 18.2 In all cases that are not provided for in this Notice of Competition or other regulations of the Streetball 3x3 Basketball Championship, MKOSZ, the organizing partner of MKOSZ, or the on-site competition office will decide.
